Terms & Conditions

1. Introduction

2. Terms to Enter the Contest

- 2.1 The Promotion is open to Xtream Markets Ltd for all the clients, And aged 18 or over at the time of entry. You are not eligible for the Promotion if you are materially connected to the administration of the Promotion.
- 2.2 Only closed trades participate in volume counts.

- 2. Open standard trading account.
- 3.Login your account with username & password.

4. Other General Terms & Condition:

- 4.1 This is limited time period contest.
- 4.2 The winners list will be announced between 1st to 15th of every month.
- 4.3 Your cashback return amount will be credited to your wallet ID within 30 days of claiming your prize.

4. Other General Terms & Condition:
