RAMADAN 50% TRADABLE BONUS

Terms & Conditions

By entering, you agree to be bound by these terms and conditions.

1.1 The Promotion is organized and run by Xtream Markets Ltd, hereinafter referred to as the Promoter.

2. Terms to enter the contest

2.1 This is the one month period offer from **18th March'24 to 19th April'24**

2.2 The Promotion is open to Xtream Markets Ltd for all the clients, and aged 18 or over at the time of entry. You are not eligible for the Promotion if you are materially connected to the administration of the Promotion.

Other Terms & Conditions

- **Eligibility:** This offer is available to clients who deposit exactly \$500 into their trading account. The deposit must be a fresh deposit and not a result of internal transfers or withdrawals followed by redeposit.
- **Bonus Credit:** Clients must open a Ramadan 50% Tradable Bonus account to participate in this offer. A 50% bonus, amounting to \$250, will be credited to the client's account within 24 hours after the deposit is made.
- **Funding and Bonus Activation:** After transferring the required amount, clients should contact customer support or their account manager via email to have their bonus credited.
- **Trading Period:** Clients are allowed to trade for 30 days following the account creation. After this period, trading capabilities in the account will be disabled.
- **Bonus Validity:** The bonus will be credited to accounts created and funded until the 19th of April. The 30-day trading period commences from the date of account creation.
- **Withdrawal Condition:** After the bonus is claimed client is not eligible to take any withdraw or transfer back the amount to wallet until the promotion period of 30 days is over .
- **Trading Requirements:** Clients must complete a minimum of 5 standard lots to be eligible to withdraw the profits and the bonus amount within 30 days. Failure to meet this requirement will result in the cancellation of both the profits and the bonus. The remaining balance will be transferred to the client's wallet.

- **Trading Conditions:** The Ramadan 50% Tradable Bonus is subject to a 2-minute 2-pip condition, which means that you must hold your trades for at least 2 minutes and have a minimum difference of 2 pips between the opening and closing prices.
- **Trade Size and Limit:** The maximum lot size per trade is 0.10, and the maximum number of concurrent open orders is 20.
- **Hedging and EA:** Hedging and EA is strictly prohibited under this bonus scheme
