Terms to Enter the Contest

The Promotion is open to Xstream Markets Ltd for all the clients, and aged 18 or over at the time of entry. You are not eligible for the Promotion if you are materially connected to the administration of the Promotion.

You can participate in the promotion by open **Ramadan special tradable account** from member area and deposit minimum 250\$, Individual have to maintain minimum deposit .**The deposit must be a fresh deposit and not a result of internal transfers or withdrawals followed by redeposit.**

Other Terms & Conditions

- **Trading Period:** Clients are allowed to trade for 30 days following the account creation. After this period, trading capabilities in the account will be disabled.
- **Bonus Validity:** The bonus will be credited to accounts created and funded for 30 days only. The 30-day promotion trading period commences from the date of account creation.
