The purpose of this Policy is to ensure compliance with applicable laws, sanctions requirements, risk management standards and internal business policies.

2. POLICY OBJECTIVE

The Company seeks to:

- Comply with international sanctions;
- Manage regulatory risks;
- Prevent unlawful use of its services;
- Protect the integrity of its business operations.

The Company reserves the right to restrict access to its services in any jurisdiction at its sole discretion.

3. PROHIBITED JURISDICTIONS

The Company currently does not provide services to residents, citizens or persons located in:

Iran

Sudan

Syria

North Korea

Clients located within these jurisdictions are prohibited from:

- Opening trading accounts;
 - Accessing trading services;
 - Participating in promotions;
 - Utilizing Company products.

4. SANCTIONED INDIVIDUALS AND ENTITIES

The Company reserves the right to refuse services to:

- Sanctioned individuals;
- Sanctioned companies;
- Restricted organizations;
- Persons appearing on international sanctions lists.

The Company may conduct sanctions screening at any time.

5. CLIENT RESPONSIBILITY

Clients are responsible for ensuring that use of the Company's services is lawful within their jurisdiction.

By opening an account, the Client confirms that:

- They are not located in a restricted jurisdiction;
 - They are not acting on behalf of a restricted person;
 - They are not subject to sanctions restrictions.

6. FALSE DECLARATIONS

Where a Client provides inaccurate or misleading residency information, the Company may:

- Suspend the account;
- Freeze transactions;
- Restrict withdrawals;
- Close open positions;
- Terminate the account.

The Company may take additional actions where required.

7. ONGOING VERIFICATION

The Company reserves the right to perform ongoing checks relating to:

- Residency;
- Nationality;
- Geographic location;
- Sanctions exposure.

Additional documentation may be requested at any time.

8. CHANGES TO RESTRICTED JURISDICTIONS

The list of restricted jurisdictions may be amended at any time.

Additional countries or territories may be added where:

- Regulatory requirements change;
- Sanctions are introduced;
- Risk assessments require restrictions.

The Company is not obligated to provide advance notice of such changes.

9. ACCOUNT RESTRICTIONS

Where a Client becomes subject to restrictions, the Company may:

- Restrict account access;
- Disable trading functionality;
- Refuse deposits;
- Refuse withdrawals where legally required;
- Close accounts.

The Company's decision shall be final.

10. FORCE OF LOCAL LAW

The Company reserves the right to refuse services in any jurisdiction where offering such services may:

- Violate local law;
- Create regulatory risk;

- Expose the Company to sanctions risk.

Availability of the Company's website does not constitute an offer of services in every jurisdiction.

11. AML & COMPLIANCE REVIEWS

The Company may conduct reviews to identify:

- Restricted residency;
- Sanctions exposure;
- Geographic inconsistencies;
- False declarations.

Clients agree to cooperate with such reviews.

12. TERMINATION OF SERVICES

The Company may immediately terminate services where:

- Restricted jurisdiction exposure is identified;
- Sanctions concerns arise;
- False residency information is provided.

Termination may occur without prior notice.

13. LIMITATION OF LIABILITY

The Company shall not be liable for losses arising from:

- Service restrictions;
 - Account closures;
 - Regulatory compliance actions;
 - Sanctions-related decisions.

The Company reserves the right to amend this Policy at any time.
